## **Carla Moynihan Joins New England School of Law as Adjunct Professor**

One concerned a public-private partnership mixed-use development project in Revere, Massachusetts for a real estate developer involving the City of Revere, the Massachusetts Bay Transportation Authority, and the Department of Conservation and Recreation. The other concerned a 75-year ground lease negotiation involving 40 acres of industrial property in South Boston owned by the Massachusetts Port Authority, which she handled on behalf of a local real estate developer.
